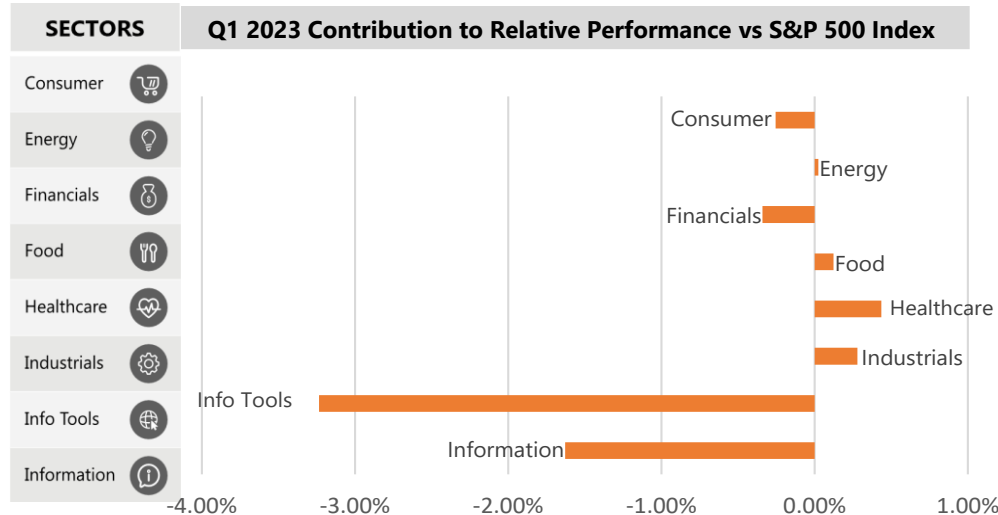
Return and Attribution Analysis

Syntax Stratified

LargeCap

SSPY

SSPY returned 3.00% in Q1 2023 versus the S&P 500 Index that returned 7.50%. SSPY's Stratified Weight seeks to diversify across sectors and sub-sectors to prevent one sector, industry, or company from becoming overconcentrated in the portfolio. The S&P 500 Index, in contrast, had over 24% of its weight in Info Tools and over 18% weight in Information. The performance of these sectors helped contribute to SSPY's relative underperformance versus the S&P 500 for Q1. Additionally, the concentration and performance of two stocks, Apple and Microsoft, accounted for approximately 12% of the average weight of S&P 500 Index, and were large drivers of the S&P 500's outperformance.



Top 10 holdings of the S&P 500 Index as of the beginning of the quarter (1/1/2023).

The chart below shows the top ten holdings in the S&P 500 Index, which represent 24.53% of the index vs. 3.44% in SSPY. The relative performance of SSPY over the Index for the top ten holdings was -3.37%.
